ORDINANCE REPEALING THE ORDINANCE ON CESSATION OF THE ORDINANCE ON PACKAGING AND PACKAGING WASTE MANAGEMENT

ARTICLE 1.

Ordinance on termination of the Ordinance on packaging and packaging waste management ("Official gazette of FBiH", No. 8/16) is repealed, acting on pursuant to the Resolution of the Competition Council of Bosnia and Herzegovina on interim measure No. 06-26-3-007- II / 16 of 30 March 2016.

Article 2.

This Regulation shall enter into force eight days after publication in the "Official gazette of the Federation of Bosnia and Herzegovina".

Pursuant to Article 42, paragraph (2), in conjunction with Article 40, paragraph (1) of the Competition Act ("Official Gazette" No. 48/05, 76/07 and 80/09), the Competition Council on the 125 meeting held on 30 March 2016, the Commission issued the

RESOLUTION ON INTERIM MEASURE

1) The request for an interim measure submitted by the undertaking Ekopak- Company for packaging and packaging waste management Ltd Sarajevo, Zmaja od Bosne Street No. 7-7a, 71000 Sarajevo, is adopted.

2) It is ordered to Federal Ministry of Environment and tourism, Marko Marulic Street No. 2, 71000 Sarajevo, to temporarily revoke the application of the Ordinance on termination of the Ordinance on packaging and packaging waste No.: 04-23-1334/15 of January 21 2016 ("Official gazette of the Federation BiH" No. 8/16).

Explanation

Competition Council on 19 February 2016 under the number 06-26-3-007-II/16 received a Request for initiation of proceedings (hereinafter: Request) submitted by the Ekopak - Company for packaging and packaging waste management Ltd Sarajevo.

In view of the above, the Competition council has preliminarily found violation of the Article 4. paragraph (1) of the Competition law in terms of the Ordinance limiting the market in a way that imposes the obligation of operators of the system to all obligations, including all contracts that have concluded with the other undertakings (polluters and collectors), and the remaining unspent financial funds transfer to the Governmental Environmental Protection Fund FBiH, by which directly closes the market and eliminate competition or disables businesses of the operators of the system for packaging waste management who owned valid licenses.
