**DECISION**

**ON THE APPOINTMENT OF THE COORDINATION COUNCIL FOR MONITORING THE IMPLEMENTATION OF THE ORDINANCE ON PACKAGING AND PACKAGING WASTE MANAGEMENT**

**I.**

The Coordination Council for Monitoring the Implementation of the Ordinance on Packaging and Packaging Waste Management (hereinafter: the Coordination Council) is hereby appointed, consisting of:

1. **Margareta Krešić**, Chair – Environmental Protection Fund of the Federation of Bosnia and Herzegovina,
2. **Ejub Salkić**, Member – Federal Administration for Inspection Affairs,
3. **Jasmin Osmanović**, Member – "Eko život" d.o.o. Tuzla, Authorized System Operator for Packaging and Packaging Waste Management,
4. **Amela Hrbat**, Member – "Ekopak" d.o.o. Sarajevo, Authorized System Operator for Packaging and Packaging Waste Management,
5. **Dunja Petrušić**, Member – Federal Ministry of Environment and Tourism.

**II.**

The members of the Coordination Council are appointed for a period of four years.

**III.**

For their work and engagement in the above-mentioned tasks, the members of the Coordination Council shall be entitled to a monetary remuneration, which shall be provided by the Environmental Protection Fund of the Federation of Bosnia and Herzegovina.

**IV.**

As of the day this Decision enters into force, the Decision on the Appointment of the Coordination Council for Monitoring the Implementation of the Ordinance on Packaging and Packaging Waste Management ("Official Gazette of the Federation of BiH", 45/13, 93/14, and 90/16) shall cease to be valid.

**V.**

This Decision shall enter into force on the day of its adoption and shall be published in the “Official Gazette of the Federation of Bosnia and Herzegovina.”
