

On the basis of Article 19. Paragraph 2 of the Law on the Government of the Federation of Bosnia and Herzegovina ("Official Gazette of BiH", no. 1/94, 8/95, 58/02, 19/03, 2/06 and 8/06), in accordance with Article 26 of the Ordinance on Packaging and Packaging Waste Management ("Official Gazette of BiH", No. 88/11 and 28/13), the Government of the Federation of Bosnia and Herzegovina, on the emergency 26th meeting held on 03.06.2013. delivers the

**DECISION ESTABLISHING THE COORDINATION COUNCIL TO MONITOR THE
IMPLEMENTATION OF THE ORDINANCE ON PACKAGING AND PACKAGING WASTE
MANAGEMENT**

I.

This resolution establishes the Coordinating body for monitoring the implementation of the Ordinance on Packaging and Packaging Waste Management ("Official Gazette of the FBiH", No. 88/11 and 28/13), (hereinafter referred to as the Coordination Council).

II.

Coordination Council consists out of one representative of the following subjects:

1. Fund for the Environmental Protection of the FBiH,
2. Federal Administration for Inspection,
3. Authorized Operator(s) of Packaging and Packaging Waste Management,
4. Federal Ministry of Environment and Tourism.

III.

The task of the Coordination Council is monitoring and coordination of all activities related to the implementation of the Ordinance of Packaging and Packaging Waste Management ("Official Gazette of BiH", no. 88/11 and 28/13), and in particular:

- Examination of periodical and annual reports, including a financial component, of the authorized operators of packaging and packaging waste management system.
- Examination of periodical and annual reports of the environmental inspection and market inspectors of the Federal Inspection Administration, regarding the inspection of the Ordinance implementation.
- Examination of the annual plan for the proper expenditure of funds from the Environmental Protection Fund of the FBiH, which should be set in accordance with the Federal Ministry of Environment and Tourism.
- Establishment of a unified registration system on packaging and packaging waste as part of the Register of plants and pollution of the Federal Ministry of Environment and Tourism.

IV.

Members of the Coordination Council shall be appointed for a term of four years.
Coordination Council shall hold meetings as needed, but at least four (4) times a year.
Administrative support to the work of the Coordination Council and the financial resources

necessary for its operation will be secured by the Environmental Protection Fund of the Federation of Bosnia and Herzegovina. Coordination Council shall, at the first constituting meeting, adopt its Rules of Procedure.

V.

Coordination Council shall, through the Federal Ministry of Environment and Tourism, submit an annual report to the Government of the Federation of Bosnia and Herzegovina on the activities carried out on the implementation of the Ordinance of Packaging and Packaging Waste Management ("Official Gazette of BiH", No. 88/11 and 28/13), no later than the end of April next year.

VI.

The Government of the Federation of Bosnia and Herzegovina shall in its resolution appoint the members of the Coordination Council, which will consist out of one representative of the entities referred to in Article II of this decision, taking into account that each authorized operator has one representative.

VII.

This decision shall enter into force on the day following its publication in the "Official Gazette of the Federation." V. No. 434/2013

**RESOLUTION ON THE APPOINTMENT OF THE MEMBERS OF THE COORDINATION

I.

The Coordination Council for the monitoring of the implementation of the Ordinance on Packaging and Packaging Waste Management ("Official Gazette of BiH", No. 88/11 and 28/13) (hereinafter: Coordination Council) is appointed in the following composition:

- 1) Safet Harbinja, Chairman of the council, on behalf of the Fond for the Enviromental Protection of the Federation of BiH,
- 2) Dragica Filipović Ćurak, member of the Council, on behalf of the Federal Administration for Inspection,
- 3) Amela Hrbat, member of the Council, on behalf of the authorized packaging and packaging waste management operator, "Eko-pak" d.o.o Sarajevo
- 4) Mehmed Cero, member of the Council, on behalf of the Federal Ministry of Environment and Tourism.

II.

The members of the Coordination Council are appointed on a four year term.

III.

For their work and engagement in the mentioned services the members of the Coordination Council are entitled to a monetary remuneration that will be provided by the Environmental Protection Fund of the Federation of Bosnia and Herzegovina.

IV.

This resolution enters into force on the day of its delivery and it shall be published in the "Official gazette of the Federation of BiH".
